EXECUTIVE ORDER NO. 28 Series of 2021

RE-ORGANIZATION OF THE MUNICIPAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN IN SAN SIMON, PAMPANGA

WHEREAS, Republic Act No. 9208 declares that the State shall give highest priority to the enactment of measures and development of programs that will promote human dignity protect the people from violence and exploitation, eliminate trafficking in person and mitigate pressures for involuntary migration and servitude of persons to ensure their recovery, and reintegration;

WHEREAS, Republic Act No. 9262, underscore the commitment of the State on safeguarding the dignity of women and children while guaranteeing full respect of their human rights and to protect them from violence and threats to their personal safety and security;

WHEREAS, these two laws provide stronger mandates and direction to relevant government agencies and stakeholders to immediately address human trafficking and VAWC by organizing Inter-Agency Councils; and

WHEREAS, cognizant of the important roles and responsibilities of the field offices of national government agencies and local government units in the effective implementation of these laws and in the prevention and monitoring of trafficking and VAWC Cases at the local level, there is a need to strengthen the local structure that will collaboratively address the problem.

NOW THEREFORE, I, ABUNDIO S. PUNSALAN JR., Chief Executive, by the virtue of the power and authority vested in me by law, do hereby order:

SECTION 1. Composition. There Committee shall be composed of the following:

SECTION 2. DUTIES AND RESPONSIBILITIES. The Committee shall;

- Institute policies and programs to protect women and children who are victims of trafficking and violence (formulate local ordinances and resolutions)
- Create and establish systems on surveillances investigation and rescue to ensure effective and efficient coordination;
- Undertake information, education and advocacy campaign against trafficking in person and VAWC.
- Monitor and oversee the strict implementation of RA 9208, RA 9262 and other related laws for the protection of women and children and of the IACT and IACVAWC national plans of action; and
- 5. Implement the program and activities as started in the national plan of action.

SECTION 3. EFFECTIVITY. This Executive Order shall take effect immediately upon signing.6

Done in San Simon, Pampanga this 16th day of March in the year of Our Lord Two Thousand <u>Twenty One</u>.






No Trafficking in Person cases were reported from January to December, 2021

STATISTICAL REPORT OF VAW CASES REPORTED IN BARANGAY, MSWDO AND PNP FOR THE YEAR 2021



In the year 2021, there were 73 reported cases victim of Violence Against Women in which 27% of them were victims of Physical Abuse, 4% were Sexual Abuse, 43% were Psychological/ Emotional Abuse while the remaining 26% were victims of Economic Abuse.

STATISTICAL REPORT OF VAC CASES REPORTED IN BARANGAY, MSWDO AND PNP FOR THE YEAR 2021



In the year 2021, there were 43 reported cases victim of Violence Against Children in which 40% of them were victims of Physical Abuse, 9% were Sexual Abuse, 49% were Psychological/ Emotional Abuse while the remaining 2% is Child Neglect.


