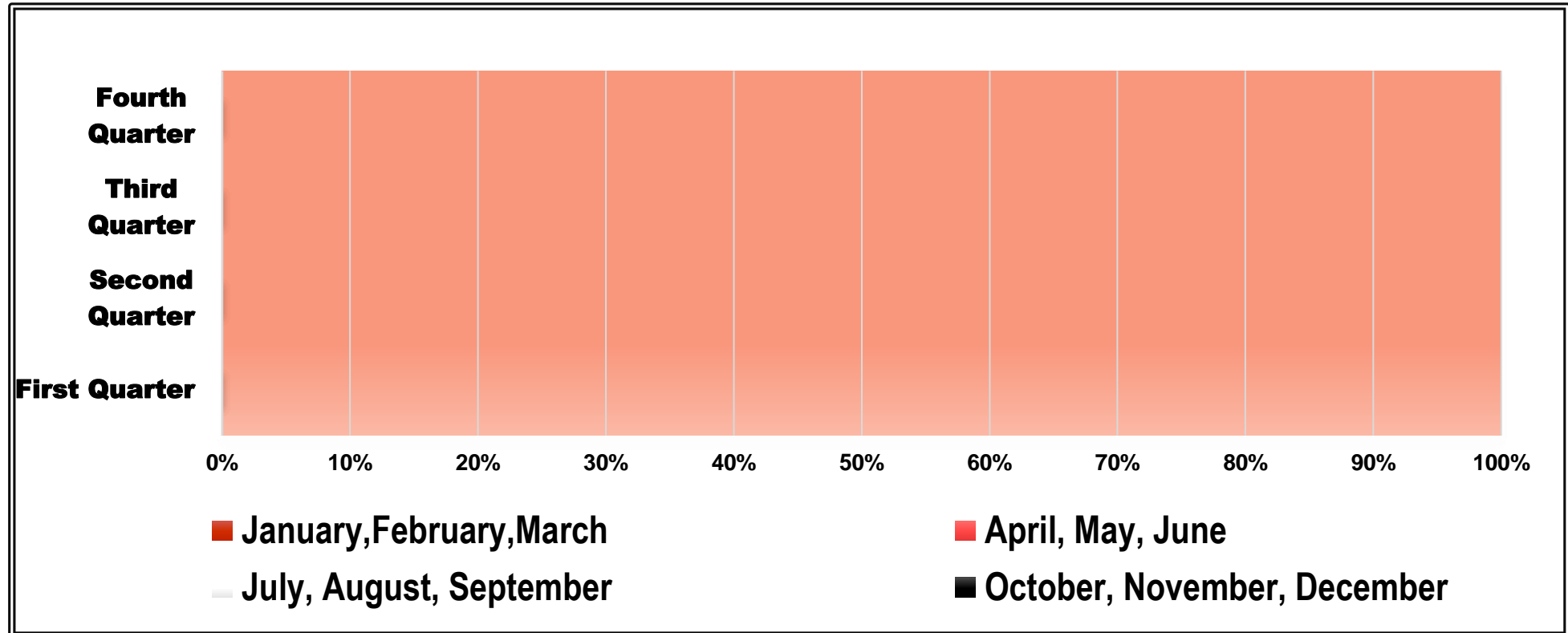

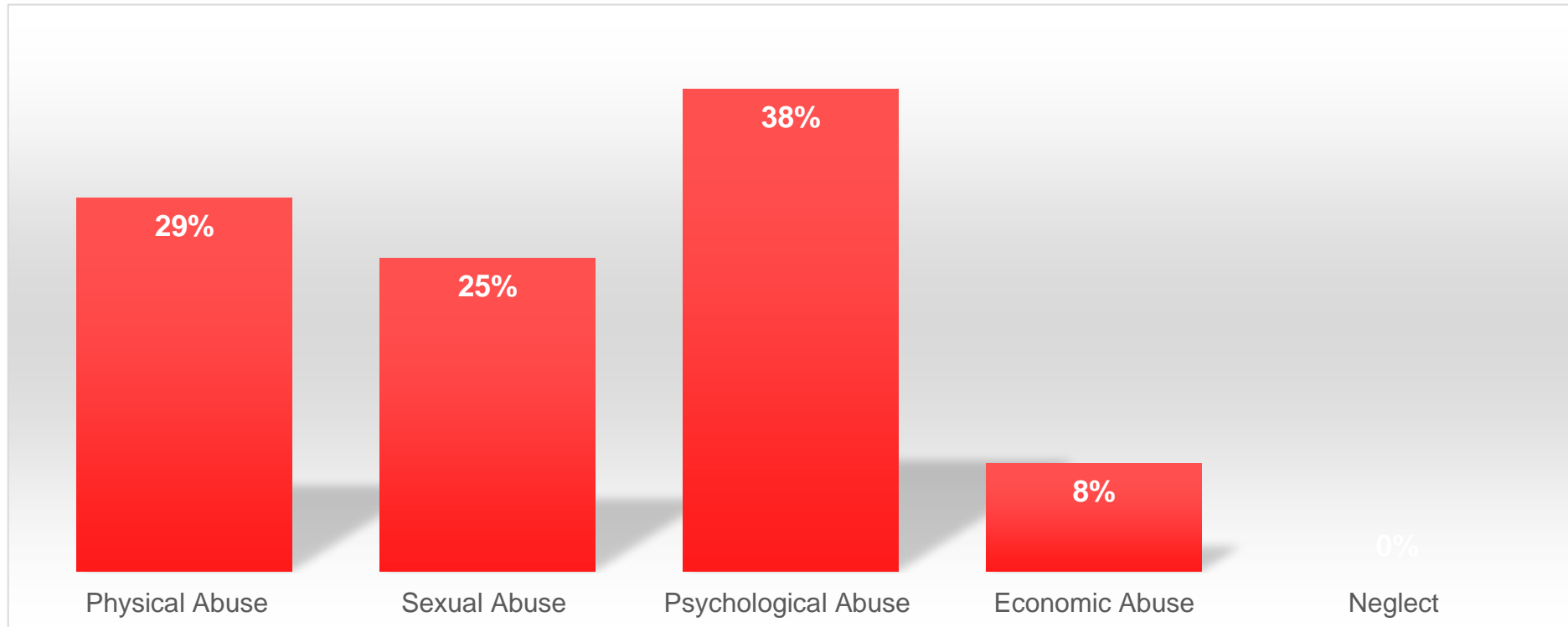

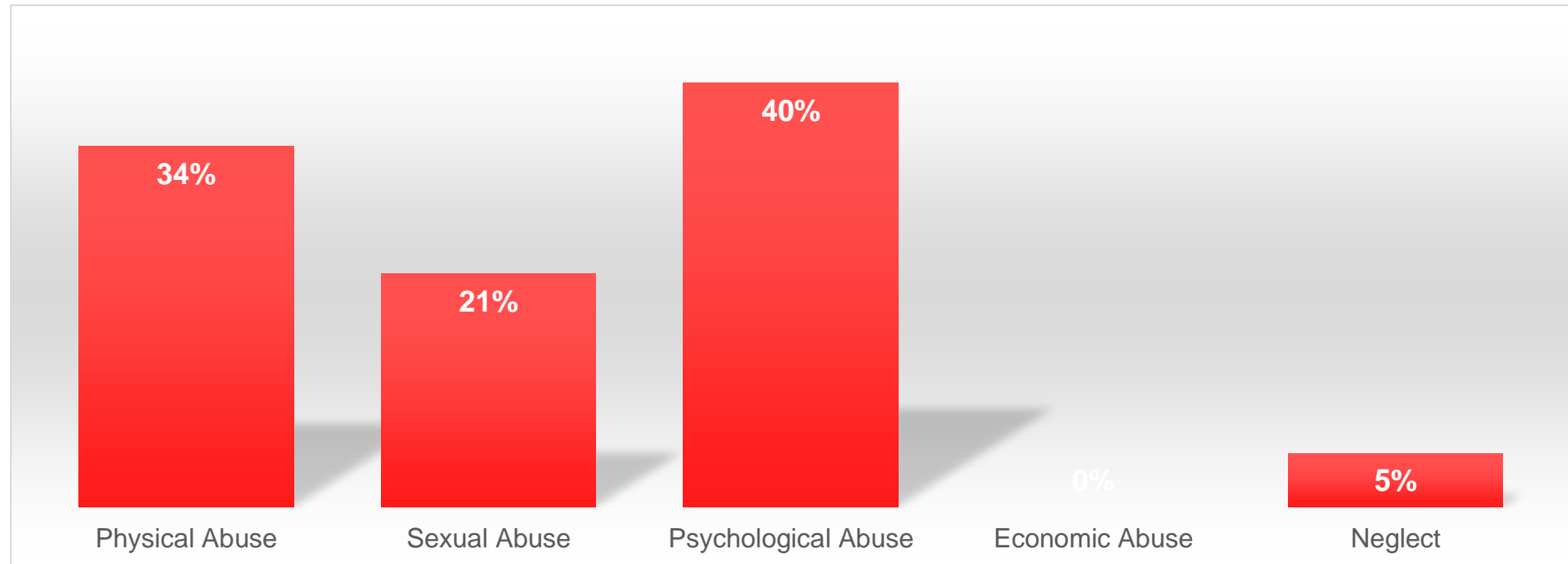

# STATISTICAL REPORT OF VAW CASES REPORTED IN BARANGAY, MSWDO AND PNP FROM JANUARY TO DECEMBER 2022




For the year 2022 there were 60 cases reported of Violence Against Woman in which 38% of them were Psychological/Emotional Abuse, 29% were Physical Abuse, 25% were Sexual Abuse while the remaining 8% were victims of Economic Abuse.

# STATISTICAL REPORT OF VAC CASES REPORTED IN BARANGAY, MSWDO AND PNP FOR THE YEAR 2022



For the year 2022 there were 49 cases reported of Violence Against Children in which 40% of them were Psychological Abuse, 34% were Physical Abuse, 21% were Sexual Abuse while the remaining 5% were Neglect.

- Dati o kasaluhuyang nobyo
- Anak ng babae lehitimo man o hindi



### "PANG-AABUSO SA MGA KABABAIHAN AY WAKASAN!"

### MGA URI NG PANG-AABUSO

1. Karahasang PISIKAL gaya ng pananampal, panununtok, panggugulpi at paninipa.
2. Karahasang SEKSUAL gaya ng pang-gagahasa at pambabastos.
3. Karahasang SIKOLOHIKAL gaya ng pananakit, pamamahiya sa publiko, madalas na pag-mumura at pangangaliwa.
4. Abusong PAMPINANSYAL gaya ng hindi pagbigay ng suportang pinansyal, pahkuha ng kita ng babae, pagpigil sa paghahanap-buhay ng babae.



### SINO ANG PWEDENG MAGHAIN NG KASO SA ILALIM NG BATAS NA ITO?

KAHIT SINONG TAO ay pwedeng maghain ng reklamo o magsumbong BASTA MAY PERSONAL NA KAALAMAN sa nangyaring kaso ng pang-aabuso.

### SINO ANG MAARING MAKASUHAN SA PAGLABAG SA R.A. 9262?

Kahit sino LALAKI man o BABAE. Pwedeng makasuhan ang babae na karelasyon (lesbian partners o girlfriends) o kasalukuyang karelasyon ng biktima na nagkaroon ng "Seksual o Dating" na relasyon.

### PANO KUNG ANG LALAKENG ASAWA O KARELASYON ANG NAGREKLAMO UKOL SA PANG-AABUSO?

Maaring magreklamo sa ilalim ng "Revised Penal Code"

### ANO ANG PROTECTION ORDER?

Ito ay isang order na kung saan ipinagbabawal ang anumang pakikipag-ugnayan sa biktima at sa anak nito sa taong nag-abuso.

- Barangay Protection Order – ito ay binibigay ng barangay at may labing-limang araw na bias.
- Temporary Protection Order – ito ay ibinibigay ng korte at may tatlumpong araw na bisa.
- Permanent Protection Order – ito ay ibinibigay ng korte at may panghabang-buhay na bisa.

ANG PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE ay nagbibigay ng pinansyal na tulong para sa mga biktima na may kasalukuyang dumadalo sa korte.

### Ang mga sumusunod ay kailangan upang makapag-apply:

- General Intake Sheet na galling sa City/Municipal Social Welfare & Development Office.
- Police Report o Investigation Report na galling sa Prosecutors Office.
- Birth Certificate ng biktima.
- Photocopy ng I.D. ng biktima.
- Pag conduct ng counseling services sa mga biktima.



### ANO ANG MGA PWEDENG MAGING PARUSA KAPAG NAPATUNAYAN NA LUMABAG SA BATAS?

- Pagkakulong.
- Multa na Php 100,000 hanggang Php 300,000.
- Mandatoryong "Psychological Counseling".

### ANO ANG BATTERED WOMEN SYNDROME (BWS)?

Ito ay koleksyon ng mga sikolohikal na sintomas na resulta ng mahabang panahon ng pang-aabuso.

Ayon sa batas, ang babaeng nagkamit ng karahasan laban sa kanyang asawa bilang depensa sa sarili ay maaring dumaranas nito.

Ang sinumang biktima na dumaranas nito ay dapat ipakonsulta sa psychiatrist o psychologist upang matugunan ang kanyang kondisyon.

### ANO AND CAPIN?

Ang Child Abuse Prevention and Intervention Network (CAPIN) ay isang programang idinesenyo upang maging istraktura ng pamayanan na may polisiya at stratehiyang may adbokasiyang nangangalaga sa kapakanan ng mga bata tungo sa pag - iwas at pangangasiwa sa mga kasong pang - aabuso sa mga bata/kabataan.

Ito ay binubuo ng isang pangkat ng propesyonal [Multi - Disciplinary Team] na nagkakaisa upang masiguro ang epektibong pagbibigay ng serbisyo sa pamamagitan ng pag - uulat at pagtatala ng mga pang - aabuso sa mga bata.

Ang mga miyembro ng pangkat ay kumakatawan sa mga ahensya ng gobyerno at pribadong sektor na responsable para sa pagsisiyasat sa mga krimen, pag protekta at pagtrato sa mga bata sa isang partikular na komunidad

### BAKIT ITO ANG KAILANGAN?

Sa kabila ng pagsisikap ng ahensya ng gobyerno at pribadong sektor, ang pang - aabuso at pagsasamantala sa mga bata ay nanatiling lagapan.

Ang paglabag sa karapatan ng mga bata ay patuloy na nagaganap.

Maraming mga kaso ang hindi inuulat dahil sa mga iba't - ibang kadahilanan, tulad ng pagkatakot na malait sa publiko, pagkasira ng dangal, at pagkawala ng pag - asa dahil sa kaisipan na walang maibibigay na magandang resulta and pagsumbong sa kinaaukulan.

### TARGET NA POPULASYON

- Biktima ng seksual at pisikal na pang - aabuso.
- Biktima ng pisikal at sikolohikal na pang - aabuso [tulad ng children in conflict with the law (CICL)] at mga batang nailigtas mula sa mapanganib na trabaho.
- Mga bata at kababaihan na biktima ng trafficking.
- Mga bata at kababaihan na biktima ng prostitusyon.

### SINO ANG MGA BATA NA NASA PELIGRO?

Mga kabataan na inabandona o napabayaan.

Out of school children

Mga kabataan na nabibilang sa magulo at hiwalay na pamilya

Mga kabataan na nasa lansangan

Mga kabataan appektado ng mga kaguluhan pang - armas

Mga kabataang hindi sumusunod sa lokal na ordinansa

### LAYUNIN
